Administrative Matters:

Dr. Darby, Chair, called the meeting to order at 6:40 p.m.

Dr. Darby acknowledged the Members present and noted the absence of a quorum necessary to conduct a regular business meeting. Dr. Darby offered an abbreviated meeting, where no cases were discussed or moved toward disposition.

A motion to adopt the meeting minutes for December 3, 2013 was offered by Ms. Roberts, seconded by Mr. Waters, and approved unanimously.

Dr. Darby expressed condolences for former CPRB Chairwoman, Marsha Hinton, whose funeral service was held earlier today. Dr. Darby acknowledged Ms. Hinton as a dedicated member of CPRB, serving the Board for more than 11 years. Ms. Hinton was relieved of her CPRB duties under unpleasant circumstances during the Ravenstahl Mayoral Administration; however she continued to passionately support the mission of the Board.

Dr. Darby announced that the Board did not meet in January due to inclement weather.

Executive Director's Report

- Ms. Pittinger thanked Dr. Darby for acknowledging Marsha Hinton and stated that she was an inaugural CPRB member who began officiating in November 1997.
- Ms. Pittinger briefly reported on the progress of the CPRB vacancy and term expirations. To
 date, no new appointments have been made to fill seats resulting from one vacancy and three

- expired terms. Ms. Pittinger stated that a meeting has been scheduled with City Council President Bruce Kraus to discuss how to expedite the appointments to the two Council vacancies; after which time she will report any progress to the Board.
- Ms. Pittinger reported on the 2014 CPRB Solicitor Contract. At this time, the proposed legislation has not yet been formally introduced to City Council for authorization: however it is expected to be finalized soon.
- Ms. Pittinger mentioned that a Public Hearing was held for CPRB case #180-13 (Henderson vs. Gromek). The Findings and Recommendations are pending a final review by the Hearing Panel comprised of Dr. Darby, Mr. Waters, and Ms. McLellan.
- Ms. Pittinger mentioned that a Pre-hearing Conference was held on 1/28/14 for CPRB case #212-13 (Ferretti vs. Kacsuta); which was continued and held today, prior to this meeting. The Hearing Officer has set forth dates for communication between the legal representatives and a follow-up discussion will be offered at the March 25, 2014 CPRB meeting.
- On January 25, 2014, Ms. Pittinger attended the Black & White Reunion's 16th Annual Summit Against Racism. Ms. Pittinger stated that the summit was well attended and she publicly acknowledged an appreciation for the work of the Black and White Reunion, including meeting attendees Mark and Tris Ozark.
- Ms. Pittinger reported that K-9 Officer Rocco died on 1/30/14 from injuries sustained during a
 citizen/police encounter in Lawrenceville. Ms. Pittinger stated that an acknowledgement of the
 loss of Rocco was conveyed through formal condolences sent on behalf of CPRB members
 and staff.
- On February 5, 2014, Ms. Pittinger was a guest on PCNC Night Talk. A general discussion was held regarding the status of the current leadership of the Pittsburgh Bureau of Police and Department of Public Safety.
- Ms. Pittinger informed the Board that Mayor Peduto publicly announced on 2/18/14, that
 former CPRB Chairwoman Deborah L. Walker has been selected as the Director of the Office
 of Municipal Investigations. Ms. Pittinger stated that she is hopeful that through mutual
 efforts, CPRB and OMI will mitigate the political resistance that has contributed to thwarting
 the Board's efforts to fulfill its mission.
- Ms. Pittinger reported that the Community Police Relation Group meetings established by US
 Attorney David Hickton reconvened on 2/21/14 for the purpose of orienting the newly
 installed City Solicitor Lourdes Sanchez Ridge and developing common discussion about
 improving the relationship between youth and law enforcement.
- Ms. Pittinger informed the Board that Former PBP Chief Harper was sentenced today, to 18 months in prison for engaging in criminal acts. Ms. Pittinger noted the unfortunateness of the circumstance; however remains hopeful that the PBP department can begin transitioning.
- Mr. Waters inquired about the status of City Council Bill No. 2013-1762, sponsored by Councilman Burgess; which proposed to allocate funding for CPRB to design a Police/Community Relations Summit. Ms. Pittinger stated that the bill expired during the last legislative session. Ms. Pittinger also noted that during a forthcoming scheduled meeting with

City Council President Kraus, the topic can be revisited; in addition to discussion regarding the two required CPRB City Council appointees and excluding CPRB from Councilman Lavelle's Public Safety Services Committee, due to the Board's independence.

Dr. Darby invited public comment. Ms. Julie Charles offered comment.

Next Meeting

Dr. Darby announced that the next regular board meeting is scheduled for 6:00 p.m., Tuesday, March 25, 2014 at the South Side Chamber of Commerce, 1100 East Carson Street, Pittsburgh, PA 15203
