Administrative Matters:

Dr. Darby called the meeting to order at 6:10 PM.

A motion to approve the 1/23/18 board minutes was offered by Mr. Williams, seconded by Ms. McLellan and approved unanimously.

Executive Director's Report:

• Ms. Pittinger reported on a 2/11/18 PBP Officer Involved Shooting (OIS) that occurred in the Homewood neighborhood and resulted in the death of Mr. Mark Daniels. The Allegheny County Police are conducting an investigation into the incident; results will be submitted to the District Attorney for assessment of any criminal culpability of the officers. Until then, and as with all criminal inquiries, the CPRB must refrain from investigating the incident but will continue to monitor any activity. On 02/15/18, Ms. Pittinger attended a community meeting at the Kingsley Association, convened by Zone 5 Commander Jason Lando. The purpose of the meeting was to vet concerns and correct misinformation. On 02/16/18, Community Empowerment Association President & CEO Rashad Byrdsong hosted a press conference seeking release of timely and accurate investigative information, including identity of the officer. Several people attended the press conference, including family and friends of Mr. Daniels, community leaders, and ACLU representatives.

- Ms. Pittinger stated that PBP Officer Souroth Chatterji filed a federal whistleblower lawsuit against the City of Pittsburgh and Linda Rosato-Barone who is an Assistant Chief of Police and Assistant Director of Public Safety. Officer Chatterji's complaint alleges retaliation, harassment and denial of promotion for investigating the relationship between software vendor, B-III Solutions, and the city of Pittsburgh, Bureau of Police and Ms. Barone; a response to the complaint is due by 3/13/18.
- Ms. Pittinger stated that the on 1/26/18, the Attorney General charged retired PBP Homicide Detective Margaret Sherwood with false swearing, unsworn falsification, tampering with evidence, obstruction, hindering apprehension and false imprisonment; the charges stem from her involvement in two separate homicide cases.
- Ms. Pittinger stated that the Findings and Recommendations of the public hearing into CPRB Case #70-15 (Sorock V. Gardner) were conveyed to the Chief and Mayor on 12/8/17 with an initial response due on 1/26/18. The Commander of the Administrative Branch learned and informed Ms. Pittinger that the Assistant Chief tasked with preparing the Chief's response did not do so before retiring. The CPRB Hearing Panel authorized an extension until 2/26/18.
- On 1/25/18, Ms. Pittinger participated in PCTV-21 televised panel discussion on "Diversity & Civil Rights" hosted by Mr. Ralph Watson of Classis Events.
- On 2/21/18, Ms. Pittinger and Ms. Gaskin participated in an 8th grade student project at Winchester-Thurston. The students were fully prepared with questions surrounding the topic of police brutality.

1. Officer Involved Shooting (OIS)

- a. According to the initial timeline of the incident issued by Allegheny Co. Police, at approximately 1:11 a.m. on Sunday morning, 2/11/18, Mr. Mark Daniels was observed by two PBP police officers to exit Betts Market at 800 Brushton Ave. The PBP officers were walking on Neuman Way, an alley to the west and running parallel to Brushton. Mr. Daniels and the officers proceeded to walk their respective southerly courses toward Bennett Street which runs East-West. There is no known contact between the police unit & Mr. Daniels until shots were fired near the intersection of Neuman Way and Bennett Street.
- b. The PBP reported that upon approach of the officers on Neuman Way to Bennett St., Mr. Daniels came from the corner of Bennett and fired upon the officers. One officer returned fire and the officers pursued Mr. Daniels. It's reported that a second shot was fired by the same officer in the course of the foot pursuit. Mr. Daniels entered a

- poorly lit area and the pursuing officers lost sight of him. Mr. Daniels was located in the back of a residence bleeding profusely and upon discovery reports state that immediate medical assistance (including CPR) was rendered and maintained until medics arrived. Mr. Daniels was transferred to a hospital where he died. The Medical Examiner attributed Mr. Daniels death to a gunshot wound to the left shoulder that severed an artery.
- c. Allegheny County Police are conducting the investigation into this OIS. Since 1996 the PBP has been required to ask an outside police agency to investigate any OIS involving Pittsburgh police. The protocol in the City Code allowed the option of asking the Allegheny County Police or the PA State Police to conduct such investigations. In 2017 the City & County formalized a protocol that appoints Allegheny County Police as the official police agency designated to conduct investigations of any OIS involving PBP officers.
- d. The report compiled by the Allegheny County Police will be turned over to the District Attorney for assessment of any criminal culpability residing with the PBP officers. Until the criminal inquiry is concluded, the CPRB must refrain from actively investigating the incident (§662.05(g)).
- e. On 2/15/18 a community meeting was convened by Zone 5 Commander Jason Lando to vet concerns and correct misinformation about the incident. A large crowd attended and PBP supervisors were also available to respond to questions. The meeting was high in tension and suspicion of the officers' actions that resulted in the death of Mr. Daniels. Cmdr. Lando emphasized his belief that absent provocation Mr. Daniels fired upon the officers barely missing one officer's head with three discharged rounds. The community group remained skeptical that the police officers didn't somehow antagonize Mr. Daniels and that Mr. Daniels would simply turn and shot at police officers.
- f. On Friday, 2/16/18, a press conference was hosted by Rashad Byrdsong at Community Empowerment Associates. Family and friends of Mr. Daniels implored the City and Bureau of Police to reveal the name of the officers involved, most particularly the name of the officer who fired at Mr. Daniels. Representatives of the ACLU echoed that plea and suggested that the responsible officer may be known from other OIS incidents.
- g. On 2/20/18 the Post-Gazette identified the shooting officer as Gino Macioce. The story summarizes the Officer's involvement in other OIS incidents. PO Macioce has been a PBP officer since August, 2012 and he is a Field Training Officer.

- h. We will keep the Board informed of major developments in this case.

2. Whistleblower Lawsuit Filed

- a. PBP Officer Souroth Chatterji filed a federal lawsuit against the City of Pittsburgh and Linda Rosato-Barone who is an Assist. Chief of Police and Assist. Director of Public Safety. The complaint alleges retaliation against Mr. Chatterji for investigating the relationship between a software vendor, B-III Solutions, and the City of Pittsburgh, Bureau of Police and Ms. Barone. (Public Source has reported extensively on the details in several articles available at: https://www.publicsource.org/lawsuit-pittsburgh-police-officer-faced-retaliation-from-public-safety-official-for-scrutinizing-software-projects/)
- b. Mr. Chatterji describes retaliatory and harassing acts such as the opening of a spurious OMI complaint against him, racial epithets directed at his Indian heritage, denial of promotion and harassment. The respondents' answer to the complaint is due by 3/13/18.
- c. A summary will be distributed to Board members after the filing of the respondents' answer to the complaint.

3. Retired Homicide Detective Charged

- a. On 1/26/18 the Attorney General charged Ms. Margaret "Peggy" Sherwood with false swearing, unsworn falsification, tampering with evidence, obstruction, hindering apprehension and false imprisonment. Ms. Sherwood was a Pittsburgh police officer for 27 years.
- b. We have one case in which it is alleged that Ms. Sherwood falsified information in a homicide case. Due to Ms. Sherwood's retirement in June 2017 from the PBP the case was out of jurisdiction.

4. Sorock v. Gardner

- a. Findings & Recommendations were sent to the Chief of Police and the Mayor on 12/8/17. Their response was due by 1/26/18.
- b. The Assistant Chief tasked with preparing the Chief's response did not do so prior to retiring. This was discovered on 1/31/18. The Commander of the Administrative Branch notified Pittinger of the discovery. The Hearing Panel was informed and an extension until 2/26/18 was authorized by the Panel.

- a. 1/25/18: Participated in televised discussion "Diversity & Civil Rights" hosted by Mr. Ralph Watson on PCTV-21.
- b. 2/15/18: Attended community meeting related to OIS incident on 2/11/18.
- c. 1/25/18-2/16/18: numerous media interviews related to Sherwood, Chatterji, OIS.
- d. 2/21/18: Wnchester-Thurston, 8th grade student project, attended with Ms. Gaskin.
