## **Executive Director's Report:**

The Executive Director provided an oral report and distributed the report to all Members. The report is also attached to these minutes.

Sr. Patrice asked what has happened with the movement of getting the County Police Review Board. Executive Director Pittinger stated her understanding was the county was still talking about a review board but no one has reached out the CPRB.

Mr. Waters asked Dr. Lucas-Darby if she would like him to turn the meeting over to her and she stated she would not she would like him to continue.

Mr. Waters asked if there was any old business to discuss. There was none

Mr. Waters asked if there was any new business to discuss. There was none

Mr. Waters reported on his attendance at a recent Implicit Bias training session. He highly recommended participation in the program. Mr. Waters added that he has been to several diversity and inclusion sessions but found this Implicit Bias Training very well presented with useful & practical applications. Dr. Lucas-Darby stated that earlier in the evening she participated in a panel discussion related to the PBP's Implicit Bias project with Commander Jason Lando and Commander Eric Holmes. The Commanders related that they are receiving excellent feedback and that the demand for the presentation is very high.

### **Case Review:**

Mr. Waters moved to the case review agenda (copy attached), each group of recommendations was voted upon as recorded and copies of the agenda were made available to the public.

It was noted that on the Case Review Agenda there were only four cases with the recommendation for 30-day extensions of full investigations, not five as was indicated. The Case Review Agenda was corrected.

Due to the nature of # 162-18, Ms. McLellan asked if additional follow-up was pursued. Investigator Gamble stated she was unable to get any information from the complainant not even an officer's name.

### **Public Comment:**

Mr. Waters invited public comment. Mr. Mark Ozark offered comment. Mr. Ozark stated Chief Schubert received a standing ovation at the Concert for Peace and Unity in memory of the victims of the Tree of Life Synagogue shooting. The concert will be rebroadcasted on PBS on December 11<sup>th</sup>.

Executive Director Pittinger asked that the 2019 Board Meeting Schedule be adopted. The Board unanimously adopted the 2019 Meeting Calendar. Mr. Waters offered assistance with scheduling meeting locations.

## 2. Community/Police Activities

10/31/18: Pittinger appeared on Night Talk for discussion about the 10/12/18 bar incident involving the Pagans Motorcycle Club and undercover Pittsburgh Police Officers.

11/4/18: Meeting with W.PA and Allegheny Co. Chiefs of Police to discuss incorporation into police training the brochure You & The Police and implicit bias training/exercises.

11/14/18: Meeting with Dir. Pub. Safety Hissrich, Chief Schubert, Co. Police Superintendent McDonough, PBP Dep. Chief Stangrecki, Assist. Chief Bickerstaff, Cmdr. Holmes, Co. Police Assist. Superintendent Bryant. We discussed:

- a. a minor revision of Y&TP to emphasize safety during street encounters
- b. refresher exercises related to Implicit Bias training objectives
- c. expansion of training capacity to extend Implicit Bias Training opportunities
- d. evaluate the possibility of including Implicit Bias training at the Local Government Academy session provided for newly elected public officials
- e. reach out to insurers of municipalities for discussion of potential incentives for municipalities integrating implicit bias and use of force training into their local police training system

11/30/18: Pittinger participated in a Regional Training Day in Cleveland sponsored by the National Association for Civilian Oversight of Law Enforcement. A panel facilitated by Rev. Dr. Yvonne Conner, Cleveland Police Commission, Atty. Susan Hutson, New Orleans Independent Police Monitor and Ms. Pittinger discussed "Life after the Consent Decree".

## 3. Training Academy: Off-Duty Conduct

- **a.** Recently a probationary Pittsburgh police officer was terminated due to conduct in which he engaged while off-duty and in street clothes. Mr. Waters is interested in the content of teaching at the PBP Academy related to police conduct, on & off duty. (Mandated curriculum is attached).
- **b.** Pittinger contacted PBP Training Academy Supervisors and learned that from the moment a recruit enters the Academy appropriate conduct in all venues is emphasized. The LT. described a total immersion in expected conduct.
- **c.** Recruits are counseled on judgment regarding social media, urged to refrain from disclosing their status as a police recruit while socializing, to abide courteous social conduct norms. The PBP rules & regulations, orders, policies & procedures are reviewed and integrated into the daily rigors of the Academy experience.
