Dr. Mary Jo Guercio, Chair, called the online Zoom meeting to order at approximately 6:11 p.m.

**Opening remarks by the Chair:**

Dr. Guercio welcomed Pittsburgh Bureau Police Chief Larry Sciroto to the July board meeting.

Ms. Beth Pittinger, Executive Director, suggested the Board act on the meeting minutes from last month’s board meeting because one of the Board members will need to leave early.

*A motion to approve the 06/27/2023 Board meeting minutes was offered by Mr. Robinson, seconded by Mr. Williams, and approved unanimously.*

**Executive Director's Report:**

Ms. Pittinger introduced Pittsburgh Bureau Police Chief Larry Sciroto, the 55<sup>th</sup> police chief of the City of Pittsburgh, who was sworn-in on June 8, 2023, and wished him the best in his tenure.

Chief Sciroto thanked Ms. Pittinger for the introduction and her welcome. The Chief pledged to be as transparent and open with the Board as he would with any other community group and/or governing bodies, and to stay committed to a level of transparency within the Pittsburgh Bureau of Police, especially as it relates to the relationship with the Board. The Chief recognized CPRB's role as an advocate for the community and accountability for the Bureau, pledging to be a willing partner.

The Chief said that he and Ms. Pittinger have welcomed this opportunity to make the relationship something different from the past, spanning policy design to strategic initiatives to training. The Chief expressed his commitment to participating in any meaningful way that the Board desires or thinks is impactful and meaningful. He characterized the mutual goal as aspiring to realize a standard of professional excellence in policing, serving our community in the most appropriate and safe manner. Chief Sciroto invited questions from the Board.

Dr. Guercio added that the Board is eager to work with the Chief and looks forward to developing the relationship.

Mr. Williams thanked the Chief for attending the meeting and was pleased that he was appointed Chief of the Bureau of Police. Mr. Williams complimented Chief Sciroto on his professional development throughout his career and leadership roles, attributing his success to his consistency.

Mr. Williams reflected on the turmoil surrounding the Bureau of Police and the resulting unpleasant public perception of the Pittsburgh Police. Subsequently, many efforts were undertaken to develop better accountability and trust with the public. Mr. Williams asked what steps the Chief would take to assure the public that there will not be any regression.

Chief Sciroto replied that by providing quarterly reports on various aspects of policing such as use of force, search and seizure, traffic stop data, and arrest data, the community can assess the Bureau's performance. The PBP will be transparent with all the data they hold and are allowed to disclose to the public, and the community and the Board would be able to challenge anything that is of concern.

Chief Sciroto said that soon he would be promoting and choosing his leadership team and developing a Community Advisory Board consisting of community members and possibly CPRB members if that would make sense. The advisory board would have the same access that CPRB has in matters of interest. He believes the community drives what we do, and with that belief, he has to invite and engage the community in a meaningful way.

Mr. Raymond Robinson, with Homewood Children's Village, welcomed the Chief and shared that he looks forward to collaborating with him.

Ms. Pittinger asked the Chief to expound upon the contemplated advisory board having the same access to information as the CPRB.

The Chief said that while he was in Florida, he was able to implement innovative policies and tactics. He gave an example of issuing civil citations for juveniles, a diversion program for certain misdemeanor crimes, or low-level crimes. The child would not be introduced to the criminal justice system through traditional means, and there was a process through the juvenile(or civil) citation to redirect the youth to different services. The idea was born in the advisory board room. It was fostered and facilitated through a partnership with that board

where the community had a voice in police decision-making where otherwise they did not, and he found that to be impactful. He presented an example of how, when talking about the significance of traffic stops to marginalized communities is backed-up with data, a credibly informed discussion with community can occur. The Chief emphasized the credibility gained when officers focus on certain crimes using intelligence and data to inform decisions instead of engaging in random fishing expeditions. Such credibility invites community participation in developing strategic policing initiatives, policy, procedures, and training.

Ms. Pittinger agreed that community engagement at that level is important but also cautioned against undermining the purposes and Charter mandate of the Board. The Board is commissioned to review police policies, procedures, recruitment, hiring, training, discipline, etc. Pittinger encouraged distinction between the role and authority of the Board and the expectations of a community advisory committee.

Ms. Pittinger reflected on past experience with police administrations, sometimes guided and directed by the executive administration, which was not as forthcoming and transparent with the Board as expected by the Charter and the enabling ordinance. In 2020, the Charter was amended by referendum with an approval of 73%. That measure directed the administration to cooperate with the Board to the maximum extent. Ms. Pittinger opined that the Board and the PBP can work together on common issues, including the development of the community advisory board with the understanding that there are duties and powers reserved to the Board that cannot be delegated by anyone except through referendum.

Ms. Pittinger asked if the IAPro Blue Team would be the early warning system that the PBP would rely on for the officers' performance evaluations. The Chief answered yes, that in 2017 he had obtained funding from a private source for the system, and it has been available for the last 5 ½ years. He explained that it is a tool with two purposes: it gives real-time acknowledgment and oversight of officers in the field, and also an early warning system flagging an officer's practices and documentation related to use of force, searches and seizures, traffic stops disproportionate toward any specific ethnicity, or when they are doing the right thing. It puts all of that information in one place where, in the past, you would have to go into various programs to compile the data. It is being trialed in the Office of Municipal Investigations (OMI).

Ms. Pittinger agrees it is a good tool and is glad it is being implemented in the PBP.

Ms. Pittinger asked if the required training under Act 59 related to de-escalation and the use of force was accomplished by the Bureau. Chief Scirotto believes it is part of the MPOETC training curriculum and a mandated training, but he will get a definitive answer.

Ms. Pittinger raised questions about an inquiry open since November that she and the Chief spoke about regarding the pre- and post-supervisory promotion training, curricula, mandatory and optional sessions, etc. The Board has attempted to obtain the curricula since November 2022. Pittinger asked the Chief if there is a reason that the material cannot be given, or can he provide a clear explanation to the Board as to where the request stands. The Chief replied that he would agree to provide the outline of that training curriculum and what is covered over the two weeks of training. That outline will reflect the direction in which the PBP is moving, to outline all standards so that it is very clear to anybody how and why the PBP delivers training. Training objectives for specific instructional blocks are under development. He will provide the outline of supervisor training, noting that instructional objectives are being developed.

Ms. Pittinger informed the Chief that the Board is aware of the staffing report which raised controversy and is aware of and respects the Chief's public comments. If there is any way the Board can assist with the implementation or the assessment and analysis of those recommendations, the Board is ready, willing, and able to help. It would be consistent with the Board's Mission and possibly offer an outside view. Ms. Pittinger reminded the Chief that the Board is there to support his efforts if they are consistent with the Board's Mission and promote a healthy relationship between the community and police.

Ms. Pittinger said the only outstanding issue was the accreditation matter related to the traffic stop ordinance. One of the standards in the Pennsylvania Law Enforcement Accreditation Program ([PLEAC](#)) requires that the agency and its officers must be committed to enforcing the laws of Pennsylvania. Except for local parking ordinances, the PA Motor Vehicle Code controls traffic and enforcement of vehicle and operating standards and supersedes related local ordinances. If the City's traffic stop ordinance was implemented, it would place the Bureau and officers in a situation where they either enforce the local ordinance and lose accreditation by not enforcing the PA Motor Vehicle Code or enforce the PA MV Code in violation of the local ordinance. Philadelphia is in the same situation. The Chief said it will be the will of Council, the City's legislative body. In September, a choice will need to be made, either remain accredited through PLEAC or reinstate the traffic stop ordinance and enforce it as written by the local policymakers.

NOTE: Mr. Williams excused himself from the meeting. Quorum was lost.

Ms. Pittinger asked the Chief if there was anything he would ask of the Board. The Chief replied, just an open line of communication. Ms. Pittinger thanked the Chief.

Mr. Robinson asked if there was a way to maintain the community engagement unit and to do some other things to recruit other officers who are so inclined to do that type of community work. The Chief replied that he stands committed to a community-based model of policing. He reiterated that the Bureau will never abandon community connections and the philosophy will be applied in each Zone as appropriate to the needs of their residents.

Dr. Guercio informed the Board there was no longer a quorum and there would not be a case review.

Intake 2023: 163 complaints received through July 24, 2023.

With a heavy heart, Ms. Karen McLellan has resigned, effective Monday, July 31, 2023, due to her relocation out of the region. Ms. McLellan has been with the Board since January 2013, the successor to the late Ms. Deborah Walker, Council Seat #2, Law Enforcement Professional (LEP). Ms. McLellan served as a Pittsburgh police officer more than 30 years. At the time of her retirement, Ms. McLellan was working with the Bureau's Crisis Intervention Team developing training for officers in mental health and appropriate responses to people in crisis. She will be missed. Dr. Guercio will provide required notices of the vacancy in Council Seat #2, LEP.

Ms. Pittinger reported on two personnel appointments. Ms. Sherry Bridgett has been appointed the Community Liaison, effective Monday, July 31, 2023. Ms. Bridgett has been with the Board for about 16 years, serving as an Investigator. Ms. Bridgett has demonstrated full understanding and respect for the Board's mission and is a tremendous asset to the Board, staff, and City. Ms. Bridgett will serve the City-at-large as an

advocate for the community, facilitating communication and identifying concerns within the Board's jurisdiction. Ms. Bridgett said she was excited and ready to start the position and "hit the ground running". Dr. Guercio congratulated Ms. Bridgett.

Ms. Pittinger reported the second appointment was to the Administrative Assistant. Da'Mesha Carpenter will be the Administrative Assistant effective Monday, August 7, 2023. Ms. Carpenter is a graduate of Alabama State University in Montgomery, Alabama. She attained a Bachelor of Arts degree in political science with a minor in legal studies. Ms. Carpenter also interned in CPRB's office and the City's Ethics Hearing Board in the summer of 2019. We enthusiastically welcome Ms. Carpenter's return to the team.

Pittinger reported that two Investigator positions will be posted in the Fall, and she is confident that the positions will be filled quickly.

Ms. Pittinger reminded the Board they do not meet again until September.

Dr. Guercio said the Board should have more conversations with the Chief about the proposed community advisory board. The Board will be vigilant and hopefully have an opportunity to participate in the development of the advisory board should its development proceed. Ms. Pittinger noted that the Board needs to be careful that such involvement does not inadvertently undermine the Board's ability to discharge its duties. The authority that was granted to the Board in the Charter and the enabling ordinance is unique to the Board.

#### **Case Review:**

Dr. Guercio again informed the Board that there was no longer a quorum and there would not be a case review.

Ms. Pittinger asked the members who were still present if they were satisfied with the response that the curriculum is being developed for the pre- and post-supervisory promotions. Ms. Pittinger believes she has the answer to the question, and it was unnecessary to execute a subpoena for the training material. Solicitor Ward said he wants to see the outline offered by the Chief before forming an opinion on the matter. Mr. Robinson asked if the outline was forthcoming because of the Chief's presence and his action or if the ball was already in motion. Ms. Pittinger replied she did not know.
