Dr. Mary Jo Guercio, Chair, called the online Zoom meeting to order at approximately 6:06 p.m. Dr. Guercio acknowledged the presence of a quorum.

A motion to approve the 07/25/2023 Board meeting minutes was offered by Dr. Darby, seconded by Mr. Green, and approved unanimously.

## Opening remarks by the Chair:

Dr. Guercio had no opening remarks.

#### **Executive Director's Report:**

Ms. Elizabeth Pittinger, Executive Director, reported to the Board that thus far, 178 complaints have been received.

Ms. Pittinger informed the Board that the staff had a remarkably busy break, with community engagement at the forefront. Ms. Sherri Bridget, Community Liaison, has been out city-wide, engaging with residents, attending Public Safety Committee meetings, and attending each of the community conversations that CPRB has participated in with Chief Scirotto and our partners. Ms. Pittinger thanked Ms. Bridgett for the excellent work she has been doing in the community.

Ms. Bridgett, Ms. Hampton, and Ms. Pittinger spent the afternoon at Chadwick Park in the Lincoln/Belmar neighborhood on August 27 for Ms. Amber Sloan's 8<sup>th</sup> annual Community Day Backpack giveaway.

Ms. Pittinger introduced CPRB's Administrative Assistant, Ms. Da'Mesha Carpenter. Ms. Carpenter has been a tremendous asset. Ms. Carpenter was a shared intern with CPRB and the Ethics Hearing Board in 2019. She has since graduated from the University of Alabama in Montgomery. Ms. Carpenter is currently a student in the Citizen Police Academy CPA.

Ms. Pittinger and Ms. Erin Bruni, Manager of the City's Office of Municipal Investigation (OMI), attended the opening night of the CPA last Wednesday, September 20, 2023, to initiate and participate in a discussion of police accountability.

Ms. Tiffani Hunt, CPRB Investigator, attended the Zone 4 Public Safety Council meeting where Dr. Sheila Roth, the Continuum of Support Program Manager of the City's Office of Community Health and Safety OCH&S, discussed the Office of Community Wellness. The project started a couple of years ago and is now piloting a co-response unit in Zone 1 and Zone 2, where a mental health professional will accompany a police officer on mental health calls to evaluate the situation.

Ms. Hunt explained Dr. Roth gave a presentation on de-escalation for citizens when approaching someone in a mental health crisis.

Dr. Guercio asked if the local Behavioral Health system in the neighborhood was being used, and Ms. Pittinger replied that she did not believe so.

Ms. Pittinger asked how many social workers were on staff, and Ms. Hunt replied 10 to 12, but she was not clear on the exact number of social workers that had been hired. Mr. Robinson informed the Board that he was at one of the meetings where they presented. His thoughts were that they have staff to do the ridealong, and they also have staff to do the follow-up, such as referrals and trying to link people to appropriate services. He believes they have all been hired through the City and did not believe outside providers were utilized.

Ms. Hampton and Ms. Carpenter attended the Mt. Oliver City/St. Clair Community Group meeting (FB Page) in the same neighborhood on the same evening as the Community Conversation meeting in Beltzhoover. Ms. Hampton gave an overview of the Board's mission and work. Ms. Bridgett will follow up with the group.

Ms. Hampton explained that the organization is different from the Zone 3 Public Safety Council as it is concerned with development within the local neighborhood. PO Christine Luffey was in attendance and did provide a report on police calls within the neighborhood and Zone 3. Ms. Hampton reported the group

expressed great satisfaction with PO Luffey's service. Ms. Pittinger said Ms. Bridgett would follow up, stay in touch, and be a resource to the community group if needed.

Ms. Pittinger recognized and congratulated the organizers and hosts of the Community Conversations with the Chief of Police and CPRB. The series of five meetings is sponsored by The Black Political Empowerment Project B-PEP, Alliance for Police Accountability (APA YouTube Page), The National Association for the Advancement of Colored People Pittsburgh Unit (NAACP) and The Urban League of Greater Pittsburgh. The hosts include Bethel AME Church, Northside Partnership Project, Beulah Baptist Church, Community Empowerment Association and Trinity AME Zion Church. Discussion has focused on community/police relations in the City, the community's expectations, and the realistic ability to meet them.

Ms. Pittinger thanked Dr. Emma Lucas-Darby, who attended the first of the five Community Conversations that took place at Bethel AME Church on August 24,2023. Dr. Darby commended Ms. Pittinger for representing the Board as she did. Dr. Darby said Ms. Pittinger was paired with others and tested, but she stood out and represented the Board well. The meetings are a good effort, and the community's participation is also good. Dr. Darby said that the citizens are looking and listening and that the City officials need to be responsive.

Ms. Pittinger reported that <u>Casa San Jose</u> requested the presence of a Spanish interpreter at the Community Conversations. Ms. Hampton facilitated the service through the City's Office of Immigration Services. Casa San Jose connects, supports, and advocates with and for the Latino community.

The Mayor's quarterly meeting with activists was held on Wednesday, September 6, 2023. This is a group that the Mayor invites to have a conversation with him, the Chief of Police, the Director of Public Safety, the Mayor's Chief of Staff, the Deputy Mayor, and the Chief Operating Officer. The CPRB staff was in attendance.

The discussion was about the Mayor's establishment of the Sentinel Review Task Force to review the use of force incidents involving Pittsburgh police pursuant to the controversial arrest of Ja'Shon Martin on August 25, 2023. An announcement was made that a new and elite group, the Sentinel Review Board, would review the use of force in the arrest and other policies that the activist community wants reviewed. The Mayor and staff described the group as non-disciplinary and not undermining the CPRB's authority or OMI's role. Chief Scirotto asked Ms. Pittinger to serve on this Board. Ms. Pittinger assured the Chief she would participate and will support his efforts if they remain consistent with the Board's Mission.

Also discussed at the meeting was the status of the Bureau's accreditation through the Pennsylvania Law Enforcement Accreditation Commission (PLEAC). The local traffic stop ordinance interferes with the discretion afforded officers and requires them to modify enforcement of the PA Motor Vehicle Code. PLEAC requires enforcement of PA law and puts officers in conflict with the local ordinance. As a result, the Bureau received a waiver of compliance to that standard. The Bureau's accreditation extends through 2025 at which time the waiver will be re-considered, and accreditation re-evaluated. Accreditation is a highly valued reflection of the agency's commitment to best practices and adherence to professional standards. State law pre-empts local ordinances, but local concern related to traffic stops prompted the City Council to establish local policy and justifications for traffic stops. This conflict placed accreditation in jeopardy.

Body-worn-camera (BWC) video was also discussed at the September 6, 2023, meeting. The community members present want BWC videos to be released, particularly the video of the Martin arrest. Public access to BWC video is controlled by state statute and status as evidence in a criminal investigation.

Pittinger reported that two Investigator positions have been posted and will remain open through September 29. Ms. Hampton will be scheduling interviews with potential candidates in the coming weeks. Anyone joining investigative staff must attain the Certified Practitioner of Oversight (CPO) credential through the National Association of Civilian Oversight of Law Enforcement. Certification requires 45 credit hours initially with an average of 10 credit hours annually (30 credit hours/3 years) to maintain certification. All CPRB investigators are CPO certified and must remain so throughout their employment with the Board.

#### **Case Review:**

Dr. Guercio moved to the Case Review Agenda (copy attached). Each group of recommendations was voted upon as recorded on the attached Case Review Actions.

049-23: Mr. Robinson asked if the date of December 12, 2023, was correct, and Investigator David Ellwood, , answered no, the date should be December 12, 2022.

120-23: Dr. Darby asked Investigator Tiffani Hunt if there was any communication between the officer and the complainant. Ms. Hunt responded that no, there had been no interaction between the two. There were no posted signs where the complainant parked and went to work. When she finished her workday, she came out to find her car missing. She contacted Zone 5, where she was informed that her vehicle had been towed.

187-22: Mr. Robinson asked what charges the officer was counseled on, and Investigator Ellwood responded the charges matched up with CPRB, if not word for word, then intent.

001-22: Mr. Robinson asked for a refresher report on the facts of the case. Mr. Robinson asked how long CPRB had been waiting for a response from the Public Safety Director. Ms. Bridgett responded that this is a Zone 5 sex assault case being recommended for dismissal as out of jurisdiction and should be removed from the remaining suspension list.

136-23: Mr. Robinson asked about a charge for DUI, and Investigator Ellwood responded that the charge could not have been held because the officer did not evaluate for DUI. There was no blood drawn, and there was no breathalyzer done. Ms. Brown asked if that was why the case was dismissed, and Mr. Ellwood responded that the Bureau disciplined both officers, and that was the reason for recommending dismissal as "resolved". Mr. Robinson asked if it was for the policy violations, and Mr. Ellwood responded yes.
