Dr. Mary Jo Guercio, Chair, called the online Zoom meeting to order at approximately 6:15 p.m. Dr. Guercio acknowledged the presence of a quorum.

A motion to approve the 09/26/2023 Board meeting minutes was offered by Mr. Sheldon Williams, seconded by Ms. Lakiesha Brown, and approved unanimously.

Executive Director's Report:

Ms. Elizabeth Pittinger, Executive Director, stated that Dr. Lucas-Darby expressed her intent to attend the meeting but had noted a scheduling conflict with another engagement.

Ms. Pittinger reported to the Board that, thus far, 188 complaints have been received this year. She also wanted to thank Lead Intake Director/Investigator Michelle Gamble Kirchner for her hard work. She extended congratulations and best wishes to her on her recent marriage.

Community Conversations with Chief Scirotto have concluded. Community Empowerment Association in Homewood held the fourth conversation on October 5, 2023. There was good conversation and a lot of community engagement. Zone 5 Police officers were present at this meeting.

Trinity AME Zion Church hosted the fifth and final conversation on October 19, 2023. Ms. Pittinger thanked each host of the community conversation on behalf of the Board and expressed appreciation for extending the opportunity to give an overview of the Board. Ms. Sherri Bridget, Community Liaison, also attended the Community Conversations and is well-informed on the needs and concerns that the community expressed.

Ms. Pittinger invited Mr. English Burton to join the meeting to present his approach to creating positivity by changing the nature and tone of language and messaging. Mr. English did not attend the meeting but will be invited to a future meeting.

Many people have applied for the two open Investigator Positions. These positions will be filled before the end of this year with the hope that CPRB will be operating with a full staff by the start of the new year.

Four Board members' terms will expire on October 31, 2023. These include Council Seat #1, which Ms. La'Keisha Brown currently holds; Council Seat #3, which Mr. Elwin Green currently holds; Mayoral Seat #6, which Dr. Emma Lucas-Darby currently holds; and Mayoral Seat #7, a Law Enforcement Seat, which Mr. Sheldon Williams presently holds. Ms. La'Keisha Brown succeeded Mr. Thomas Waters who resigned in 2021. City Council has confirmed Mr. Gregory Kottler as Ms. Brown's successor in Council Seat #1 and Ms. Terry Shields as Mr. Green's successor in Council Seat #3. A nominee to succeed Dr. Emma Lucas Darby in Mayoral Seat #, Mr. Daylon Davis, is pending a confirmation interview with City Council. Mr. Sheldon Williams' successor is pending mayoral action. Ms. Terry Shields and Mr. Daylon Davis attended this Board meeting.
