Dr. Mary Jo Guercio, Chair, called the online Zoom meeting to order at approximately 6:03 p.m. Dr. Guercio acknowledged the presence of a quorum.

Opening remarks by the Chair:

Dr. Guercio started the meeting by welcoming new board member Mr. Daylon Davis and explained how board meetings are conducted.

Dr. Guercio proposed scheduling some upcoming meetings in person and explained that pre-COVID the Board would meet in Council Chambers and local community centers. This discussion will be revisited at the February meeting.

Executive Director's Report:

Ms. Elizabeth Pittinger, Executive Director, welcomed Mr. Daylon Davis to the Board. Mr. Davis was sworn into his seat on the Board on January 16, 2024. He will succeed Dr. Emma Lucas-Darby in the non-law enforcement professional seat designated as Mayoral seat number six. This term will expire on October 31st, 2027.

Ms. Pittinger introduced and welcomed the new CPRB Investigator, Ms. Nicole Edwards, who was in attendance. Ms. Edwards was appointed to her position on December 18, 2023.

The City Code requires all newly appointed Board members and staff to attend the Citizen's Police Academy (CPA) [Student and Citizen's Police Academy | pittsburghpa.gov](https://pittsburghpa.gov). The next CPA session will begin on February 28, 2024, and will be conducted for the next 12 weeks at the Jewish Community Center in Squirrel Hill. Seats have been reserved for the three new Members and Ms. Edwards.

Ms. Pittinger also informed the Board of the Student Police Academy (SPA) [Student and Citizen's Police Academy | pittsburghpa.gov](https://pittsburghpa.gov), which is for high school students and runs for about ten weeks. It is similar to the CPA and allows students to familiarize themselves with the officers and their experience.

The annual Race and Justice Summit, formerly known as the Black and White Reunion, was scheduled for Jan 19th and 20th but was postponed due to inclement weather and illness. All will be updated when a new date is announced.

Ms. Pittinger touched on in-person meetings. If that is the Board's desire, it should be revisited in the next Board meeting so outside arrangements can be made.

Ms. Pittinger reminded the Board that confidentiality is vital when reviewing the complaints brought to the Board. Unless a complaint goes to a public hearing, all information related to a complaint must remain confidential and not discussed with anyone outside of the Board or Board staff. This requirement is established by law. There is no personally identifiable information in the summaries, which helps ensure that Members can fairly review these cases without bias or need to recuse themselves.

Ms. Pittinger reminded the Board that she and Dr. Guercio are the only two representatives authorized to speak on behalf of the Board. In certain situations, the Chair of the Board can designate a member to talk about a specific topic. Otherwise, to maintain consistency and credibility, all public statements shall be reserved to the Chair of the Board or the Executive Director.

Ms. Pittinger discussed the settlement between the City and the Estate of Jim Rogers. The parties agreed to an \$8 million dollar settlement pending approval by City Council. After the Council action, questions arose

about the foundation of the settlement. Among the concerns was the Medical Examiner's official ruling on the manner of Mr. Rogers' death as accidental. Other questions arose about Mr. Rogers' condition upon arrival and during his hospitalization, whether he was under the influence of any substance and the verification of his biological survivor(s). As these questions became more common, the Council President sought to hold payment of the initial \$4 million dollars until the questions were resolved. However, the check had already been released to the estate.

It is also known that three of the four officers who were initially fired were re-instated to their jobs through arbitration. The remaining officer's status (the original responding officer) is pending arbitration. The District Attorney (DA) has not initiated any criminal process against any officers involved in the incident. Though it has been reported that a Grand Jury did receive the case, there have been no indictments against the officers. These circumstances beg the question of who is responsible for the death of Mr. Rogers. The City Solicitor stated in a press conference that the officers are responsible for the death, and as a result, the settlement has been made. The terms of the settlement are unknown to staff though we are searching Court records for a copy of the agreement.

Mr. Daylon Davis asked why the settlement agreement could not be found. Ms. Pittinger replied that the settlement document that identifies terms and amount of \$8 million dollars was not located in the court record by staff, at least not through the week of January 19, 2024. Mr. Davis asked if a formal investigation into the incident that led up to Mr. Roger's death had been opened. Ms. Pittinger explained the DA has never issued a prosecutorial decision in the Rogers case, so CPRB had to evaluate the case in a general way, not the actions of certain officers.

CPRB investigators were at the scene of the incident the day of the incident. They spoke to witnesses and viewed local video. They found that the encounter was questionable regarding the responding officer's management of the incident. The Rogers incident is one of four instances that caused the Board to open an inquiry into the training of PBP Supervisors, including pre- and post- preparation of police supervisors.

Body Worn Cameras (BWC) Video: In 2017, the PA legislature passed a statute known as [Act 22 of 2017](#), which dealt with public access to BWC video. The law outlines how the public can request BWC video from police agencies. CPRB investigators have had the benefit of viewing BWC footage during investigations involving administrative misconduct allegations, not criminal allegations because that material is protected under the Criminal History Record Information Act ([CHRIA](#)).

The Office of Municipal Investigations (OMI) has changed its procedure for investigating complaints over the last few years. If an officer's conduct would benefit from supervisory intervention, they will refer that complaint to the Zone supervisors and not conduct a full investigation. OMI also has access to all BWC video footage, which means they can close a case without further investigation, including not collecting officer statements. Officer statements are protected under [Garrity](#) to guard against self-incrimination. the statements cannot be used in any criminal proceeding. In 2004, CPRB came to a settlement agreement with the City through a court order that, with the issuance of a subpoena, officer statements under Garrity would be obtained. This would provide the officer's perspective of the incident. Officer statements are confidential and

are not used unless the officer says something contradictory to the statement at a Public Hearing. In that case, the prosecutor use may use the statement to impeach the subject or witness officer.

The officer statements and BWC footage are essential to CPRB investigations, but they are not being received due to the recent PBP personnel changes. On November 15, 2023, Investigator Ellwood was directed by the City Solicitor to the District Attorney's office for access to body worn camera video. The City Solicitor indicated that there was an agreement between the City and the DA that controls access to BWC video.

A copy of that agreement (Memorandum of Understanding/MOU) was requested but has not been received, nor has a response been issued. The DA's office also stated that it would cost the CPRB as requestor \$600 to obtain the BWC footage. Ms. Pittinger is currently trying to schedule a meeting with herself, Mr. Ward, CPRB Solicitor, and the City Solicitor to discuss these protocols, procedural issues, and recent changes and establish protocols enabling CPRB investigators to conduct investigations and in compliance to the Charter.

Mr. Kottler asked if the Student Police Academy classes were at capacity and if students received any credit for attending the Academy. Ms. Pittinger responded that there is a certificate of completion for taking the course, but students do not receive any school credits for attending. Mr. Ward responded that the flyer stated at the very bottom that the program is not an accredited certification course to become a sworn police officer. Mr. Kottler responded he was asking in consideration of a student who might need help with credits for graduation. Investigator Hunt responded that her daughter attended the SPA. She received a certificate but did not get any credits.

Mr. Davis asked what date the MOU was asked for. Ms. Pittinger responded on November 15, 2023.

Ms. Shields asked about scheduling meetings in the community. She stated that she has a non-profit and thought that convening a Board meeting in the Hazelwood Community would be a good idea. Ms. Pittinger and Dr. Guericco advised her of the different locations the Board has been to over the years, which usually included community centers, healthy living centers, churches, etc. CPRB will usually be invited to these places or ask to be invited.

New Business:

Discuss if and when to return to Council Chambers and the community for public Board meetings.

Mr. Davis asked if the new members could be provided with a reference sheet for the different acronyms and terminology commonly used in the summaries/case reviews. Ms. Pittinger responded that a reference will be provided.

A motion to approve the 12/05/2023 Board meeting minutes was offered by Mr. Kottler, seconded by Mr. Davis, and approved unanimously.
